# FLOODPLAIN DEVELOPMENT PERMIT

The City of Joshua Floodplain Permit Program is authorized by Article 3.07.008 of City Ordinance No. 554-2012, adopted October 18, 2012. This permit is required for all development taking place within the area of the 100-year floodplain (special flood hazard areas) as shown on the current Flood Insurance Rate Maps and Flood Boundary-Floodway Maps, published by the Federal Emergency Management Agency (FEMA).

Failure to obtain a Floodplain Development Permit or violating other provisions of City Ordinance No. 554-2012 or the conditions described within the permit constitutes a misdemeanor and upon conviction, a person, firm, or corporation could be fined up to one thousand dollars (\$1,000) a day for each day that the violation occurs.

I understand that the conditions which may be stated for permit approval or the provisions of City Ordinance No. 554-2012 may be superseded by other provisions of City code or policies.

I further understand that this Floodplain Development Permit does not constitute final approval until all development requirements placed on the property have been met. These requirements include, but are not limited to, City construction plan approval, platting and community facilities agreements. This proposal shall be subject to any change in floodplain development policy at the actual time of development.

Application is hereby made for a permit to authorize the activities described herein. I hereby certify that I am familiar with the information contained on this application and to the best of my knowledge such information is true and accurate. I further certify that I possess the authority to undertake the proposed activity. I understand that if my application is denied, I have sixty (60) days from the date of such denial to appeal the adverse action to the appeal board, as established by the community.
