City Council Waiver Application Instructions

- 3. Owner affidavit form completed.
- 4. A non-refundable filing fee of \$150.00.
- 5. Any other information that you feel will help explain your request.

City of Joshua Code of Ordinances Building Regulations Signs

Section 3.06.16 Exception Request Process

- (a) Exception Authorized. After a public hearing, the City Council may authorize an exception to any restriction set forth in this Article, including, but not limited to, the number, type, area, height or setback of signs.
- (b) Approval Standards. In granting any exception, the City Council shall consider the following criteria:
 - (1) the sign's size, shape, color, design elements, or location;
 - (2) the compatibility of the proposed sign with the surrounding property, the proximity of other signs, and the characteristics of the area;
 - (3) the strict application of the requirements in this Article would result in a particular or unusual practical difficulty, or an exceptional or undue hardship on an applicant;
 - (4) the requested exception is the minimum reasonably necessary to overcome any exceptional conditions;
 - (5) whether any special conditions and circumstances justifying an exception result from the actions of the applicant and such conditions and circumstances do not merely constitute monetary or economic hardship or inconveniences;
 - (6) granting the exception will not be injurious to any adjoining property owner or otherwise detrimental to the public welfare; and
 - (7) the exception can be granted without substantial impairment of the purposes of this Article.
