ADDITIONAL INFORMATION TO SUBMIT

<u>City of Joshua Ordinance No. 418-2006, Section 5 – Gas Well Permit Required, (K) #5</u> requires: "Erosion control measures must be implemented to prevent any off-site migration of silt and sediment."

<u>City of Joshua Ordinance No. 418-2006</u>, Section 7 – Gas Well Permitting Procedure, (C) #2 requires: "If requesting waiver for a Gas Well Permit at least twenty (20) days, and no more than thirty (30) days prior to the date of the public hearing before the City Council for a waiver and the issuance of the Gas Well Permit under this Ordinance, the City shall notify, at Operator's expense, each surface owner of property, as shown by the current tax rolls of the City within one thousand (1,000') feet of the proposed well not owned by or under lease by the Operator, of the hearing location, date and time."

<u>City of Joshua Ordinance No. 418-2006, Section 7 – Gas Well Permitting Procedure, (D) #2</u> requires: "If requesting Gas Well Permit by Waiver of Protected Uses or by Certification That No Protected Uses Exist Within Protected Radius – Upon receipt of copies of all Protected Use Waivers filed in the applicable County Deed Records and a completed application by the Operator or Certification that no Protected Uses exist within a six hundred foot (600') radius around the proposed well, the City shall notify, at Operator's expense, each surface owner of property as shown by the current tax rolls of the City within one thousand (1000') feet of the proposed well not owned by or under lease to the Operator."

<u>City of Joshua Ordinance No. 418-2006, Section 7 – Gas Well Permitting Procedure, (C) #3</u> - <u>Publication Requirements For Request Of Waiver For A Gas Well Permit By The City Council</u> requires: "At least fifteen (15) days, and no more than twenty (20) days prior to the date of the public hearing before City Council for a Gas Well Permit under this Ordinance, Operator shall publish a copy of the notice as outlined below, at Operator's expense, in one issue of the local section of a newspaper of general circulation in the City for ten (10) consecutive days. An affidavit by the printer or publisher of the newspaper indicating publication of the notice shall be filed with the application and will be prima facie evidence of such publication. The notice shall read as follows:

"Notice is hereby given that, acting under and pursuant to the Ordinances of the City of Joshua, Texas, on the _______day of ______, 20_____filed with the Gas Inspector of the City of Joshua, an application for a Gas Well Permit to drill, complete and operate a well for gas upon property located at _______, Johnson County, Joshua, Texas, more particularly shown on the map of record in Volume _______, Page _____, Plat Records of Johnson County, Texas or per Tax Tract Number ______County, Texas. The City Council will conduct a public hearing on the request for said permit on the ______day of ______, 20_____at _____o'clock ____.m. in the City Council Chambers located at 101 S. Main, Joshua, Texas."

<u>City of Joshua Ordinance No. 418-2006, Section 7 – Gas Well Permitting Procedure, (D) #3 -Publication</u> <u>Requirements For A Gas Well Permit By Waiver Of Protected Uses Or By Certification That No Protected</u> <u>Uses Exist Within Protected Radius</u> requires: "At least ten (10) days prior to the date of filing of an application for a Gas Well Permit by Protected Use Waiver or Certification of No Protected Uses under this Ordinance with the Gas Inspector, Operator shall publish a copy of the notice as outlined below, at the expense of the Operator, in one issue of the local section of a newspaper of general circulation in the City. An affidavit by the printer or publisher of the newspaper indicating publication of the notice shall be filed with the application and will be prima facie evidence of such publication. The notice shall read as follows:

"Notice is hereby given that, acting under and pursuant to the Ordinances of the City of Joshua, Texas, on the ______ day of ______, 20____, an application was filed with the Gas Inspector of the City of Joshua, an application to drill, complete and operate a well for gas upon property located at _______, Johnson County, Joshua, Texas, more particularly shown on the map of record in Volume ______, Page _____, Plat Records of Johnson County, Texas. Written waivers from all protected uses property owners within six hundred feet of the proposed well were filed in the applicable County Deed Records (or) Certification was made that no Protected Uses exists within six hundred (600) foot radius of the proposed well."

<u>City of Joshua Ordinance No. 418-2006, Section 13 – Technical Regulations, (B) #2</u> requires: "The Operator shall be responsible for establishing and reporting to the City the pre-drilling Ambient Noise Level prior to the issuance of a Gas Well Permit. Once the drilling is complete, the Operator shall be required to establish a new Ambient Noise Level prior to the installation of any new noise generation equipment."

Indemnification and Express Negligence Provisions: Operator does hereby expressly release and discharge, all claims, demands, actions, judgments, and executions which it ever had, or now has or may have, or assigns may have, or claim to have, against the City of Joshua, and/or its departments, agents, officers, servants, successors, assigns, sponsors, volunteers, or employees, created by, or arising out of personal injuries, known or unknown, and injuries to property, real or personal, or in any way incidental to or in connection with the performance of the work performed by the Operator under a Gas Well Permit. The Operator shall fully defend, protect, indemnify, and hold harmless the City of Joshua, Texas, its departments, agents, officers, servants, employees, successors, assigns, sponsors, or volunteers from and against each and every claim, demand, or cause of action and any and all liability, damages, obligations, judgments, losses, fines, penalties, cots, fees, and expenses incurred in defense of the City of Joshua, Texas, its departments, agents, officers, servants, or employees, including, without limitation, personal injuries and death in connection therewith which may be made or asserted by Operator, its agents, assigns, or any third parties on account of, arising out of, or in any way incidental to or in connection with the performance of the work performed by the Operator under a Gas Well Permit. The Operator agrees to indemnify and hold harmless the City of Joshua, Texas, its departments, its officers, agents, servants, employees, successors, assigns, sponsors, or volunteers from any liabilities or damages suffered as a result of claims, demands, costs, or judgments against the City, its departments, its officers, agents, servants, or employees, created by, or arising out of the acts or omissions of the City of Joshua occurring on the drill site or operation site in the course and scope of inspecting and permitting the gas wells INCLUDING, BUT NOT LIMITED TO, CLAIMS AND DAMAGES ARISING IN WHOLE OR IN PART FROM THE NEGLIGENCE OF THE CITY OF JOSHUA OCCURRING ON THE DRILL SITE OR OPERATION SITE IN THE COURSE AND SCOPE OF INSPECTING AND PERMITTING THE GAS WELLS. IT IS UNDERSTOOD AND AGREED THAT THE INDEMNITY PROVIDED FOR IN THIS SECTION IS AN INDEMNITY EXTENDED BY THE OPERATOR TO INDEMNIFY AND PROTECT THE CITY OF JOSHUA, TEXAS AND/OR ITS DEPARTMENTS, AGENTS, OFFICERS, SERVANTS, OR EMPLOYEES FROM THE CONSEQUENCES OF THE NEGLIGENCE OF THE CITY OF JOSHUA, TEXAS NAD/OR ITS DEPARTMENTS, AGENTS, OFFICERS, SERVANTS, OR EMPLOYEES, WHETHER THAT NEGLIGENCE IS THE SOLE OR CONTRIBUTING CAUSE OF THE RESULTANT INJURY, DEATH, AND/OR DAMAGE.
